Registration: We are limited to a ‘stable’ group of 12 children a day.

To reserve a place, please remit this form with full payment. Registration is first come, first serve. I understand that registration is not guaranteed. Children must enroll for a full four-week session.

Refunds: I understand that tuition is not refundable. However, if the program is required to close due to enforced changes to restrictions due to Covid19 a full refund will be offered.

Safety Requirements: I understand and accept the restrictions as outlined by the County Health Department and Childcare Licensing that will be enforced by Tara Redwood School.

New drop-off requirements:

- Parents leave your child and pick them up at the designated outdoor place
- Parents wait with your child on a colored circle until it is your turn to meet the teacher
- A teacher will ask for a health update and take your child’s temperature.
- Children will NOT be admitted if they have had a runny nose, coughing, diarrhea, fever within the last 72 hours or if any family members have had similar symptoms.
- We request that parents remain vigilant in social distancing in order to protect your child, the other children in camp, and their families
- Your child’s lunch box, water bottle, change of clothes, bathing suit, should all be clearly labeled and in a backpack.

Behavior: I understand that this program is based on compassionate kindness. Children who cannot conduct themselves accordingly will be asked to leave the program without a refund.

Fees: I agree as a condition of enrollment in this program to pay tuition as shown above by the

first day of each session. I understand that a late fee of \$20 will be added to each session for each child when payment is in arrears.

I understand that if tuition is delinquent in excess of 5 days my child(ren) will not be permitted to return to the program until all delinquent obligations are paid in full. I understand that the program shall have the right to legal action for nonpayment of tuition and fees, and I will be responsible for all costs of collection, including court expenses and reasonable attorney's fees.

Waiver and Release

- I understand that there are inherent risks in outdoor play.
- At this time, we trust that the school and staff are taking strict precautions to protect the children in their care from the risk of contracting COVID-19.

I agree to indemnify and hold harmless Tara Redwoods and its staff for any claim that may arise from participating in this program.
